- ⊕ The era of relying on third-party solutions without **user consent** is over. A **first-party** approach to data collection & analysis is now essential.

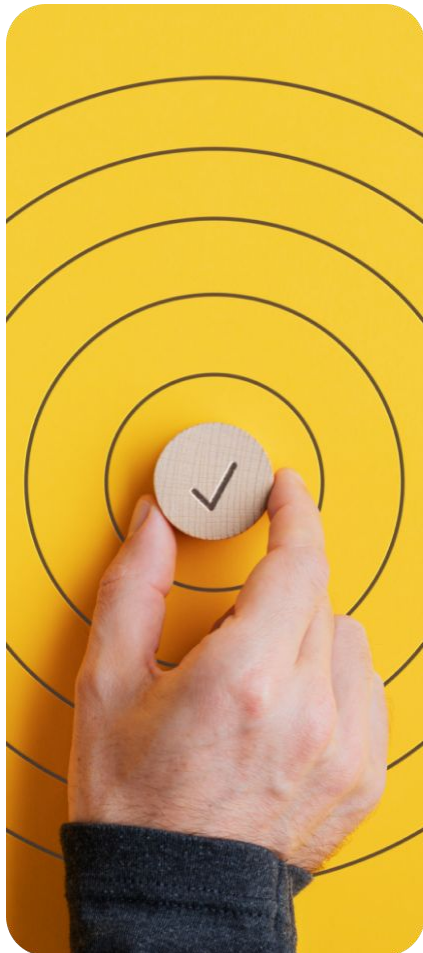

Here's what's happening

The Current Landscape of Privacy & Data Regulations

- ⊕ **May 1st** is the deadline for Consent Mode 2 support to be eligible for Google Adwords, the lack of a compliant consent model leads to a ban on digital marketing.
- ⊕ **July 1st**, Google is deleting all Google Analytics Universal Data.
- ⊕ **GDPR Rulings in the EU** including SE, NO, NL & DPAs require informed consent.
- ⊕ **Article 5(3) of the ePrivacy Directive** mandates that storing or accessing information on a user's device requires prior explicit consent.
- ⊕ **Inadequate legal consent** for data collection & processing now leads to fines.
- ⊕ Implementation & enforcement of new **Privacy, Data Protection, Digital Markets Act, Cybersecurity, AI, Health, & Minor Regulations** worldwide.
- ⊕ A shift in **international security** priorities, including a U.S. executive order on privacy, informed consent requirements in California & other states & a new **federal privacy law** in progress.
- ⊕ **Public awareness** & demand continue to drive **enforcement** of these changes.

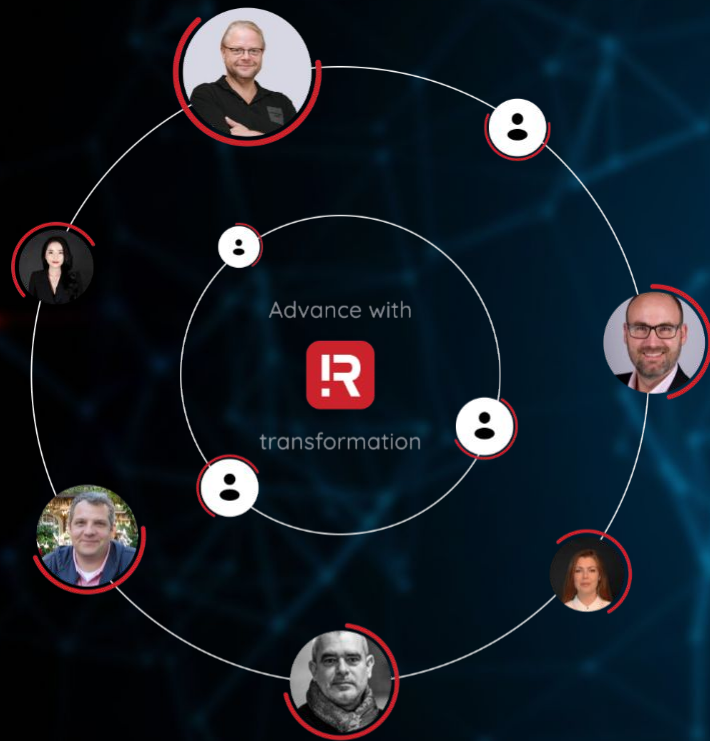
- ⊕ **Marketers spend:** Up to 20% of their digital marketing budget on retargeting, resulting in up to a 150% increase in conversion rates.
- ⊕ **Revenue Impact:** E-commerce sites that rely on retargeting could see an estimated revenue drop of 25-30% as new consent requirements come into effect, impacting the efficacy of these strategies.
- ⊕ **Data Accessibility:** With the enforcement of informed & explicit consent requirements, businesses must obtain user consent for any tracking technologies, making previously accessible data unavailable without user consent.
- ⊕ **Operational Changes:** Retargeting methods, including Recommended Products & Abandoned Cart features provided by third-party SaaS providers, will cease to function effectively without user consent.
- ⊕ **Action Required:** The urgent adoption of compliant consent management systems & first-party data based solutions that introduce data-minimization & privacy by design is necessary.
